OPPOSE HB4501



This Bill Would Make Two Main Changes to the Dental Practice Act:

1. This Bill Would REMOVE Teledentistry from Dental Hygienists' Current Scope of Practice

Teledentistry is currently used by dental hygienists in Illinois. This bill changes the definition *to provide that a person who uses teledentistry is considered to practice dentistry under the Act.* That means only dentists would be able to use teledentistry. An off-site dental hygienist would no longer be able to communicate with a dentist on the other end. Illinois dental hygienists and public health dental hygienists currently use teledentistry to communicate with their supervising dentist when providing preventive oral care at off-site locations. Off-site locations include federal, state and local public health facilities, school based health and dental centers, hospitals, FQHCs, prisons, residents of special needs and long-term care communities, public health medical and dental centers, Head Start, and Women's Infants and Children's programs. This bill could hinder preventive oral care delivered in such settings decreasing access to oral care. Supporters of this bill say the opposite.

2. This Bill Would REMOVE Licensure Requirements for Providers Treating Children and Adults

This bill would allow on-the-job-trained dental assistants to provide licensed dental provider-level care to children and adults without a high school or college education or a license to practice. Supporters say allowing dental assistants to scale is needed because a 2021 ADA study found dentists have 3% more difficulty hiring dental hygienists than dental assistants.

The "approved training" would consist of an on-the-job-trained dental assistant completing a two-day weekend course practicing on a mouth model. This "approved training" could not prepare <u>anyone</u> to safely provide oral care services. Dental assistants typically begin their careers as high school students, learn on-the-job, and do not attend college. Dental assistants are not required to complete an intense CODA-accredited dental hygiene program, pass national or multiple state board examinations, take continuing education courses, nor to be monitored or regulated by the Board of Dentistry, as are college-educated Registered Dental Hygienists licensed to provide oral care for children and adults. Dental assistants should not perform license-level oral care!

The Illinois State Dental Society introduced this bill to remove teledentistry from dental hygienists' current scope of practice and allow on-the-job trained dental assistants to provide license-level patient care. This bill suggests 16 clock hours of training would make dental assistants proficient to treat children and adults. This bill would set a dangerous precedent for Illinois! Illinois residents deserve quality oral healthcare provided by college educated licensed providers! This bill is unconscionable and dangerous! See the RDH/DA Education Comparison next page.

This bill is promoted as a *Teledentistry Bill* to increase access to care. However, it instead removes teledentistry from licensed dental hygienists' current scope of practice. These bills would further limit access to care and permit the delivery of substandard oral care. Would you want this oral "care" for yourself or your family?
